Please note these extracts and notes align with the Club's current rule book:

Notes for the Proposers:

- Any two members of not less than six months standing may propose and second a candidate for membership and shall be able *from personal knowledge* to vouch for the candidate's respectability and fitness to be a member and both of them shall sign the nomination form as shall the candidate
- Candidates must abide by the Rules of the Club in the event of being elected a member.
- No paid employee of the Club shall be a member.
- No rejected candidate shall again be proposed as a member until the expiration of twelve months from the date of such rejection.
- No person who shall have been expelled from this or any other affiliated clubs shall ever again be proposed as a candidate, or make use of the Club premises, except by express written consent of the Committee, such consent being signed by at least two Officers or members of the Committee and the Secretary.
- No person, who has at any previous time been a member of the Club, shall be eligible for re-election before the period of six months has elapsed since the expiry of that person's previous membership.

Notes for the Candidates:

- Please write clearly.
- Please note that it is normal practice for us to display Membership Application forms on the Club's notice board for a minimum of two weeks prior to the next full committee meeting. Your name, address and details will be on display for perusal by existing members and / or their visitors. The Club, although a 'members club', could be subject to the Data Protection Act. Visiting on-members may also enter the Club and view your details. If you have any queries or questions on this point, please contact the Membership Chair or Club Secretary with your view. If you don't want your contact details 'displayed' please ensure this is clearly stated on the returned forms with reason(s).
- Candidates for membership must be eighteen (18) years of age or above.
- The Committee requires that a reasonable standard of dress shall always be maintained by the candidate when entering the Club. Corporate branding is acceptable, but not hi-viz or dirty or torn clothing.
- Under no circumstances will bad language or abusive behaviour be tolerated on the Club premises.
- You may invite up to two visitors into the Club at any time, but they must "sign in" and each person is limited to two visits per calendar month; beyond that, they may as well join too!
- The Club operates a Non-Smoking policy. If you do smoke, a cigarette bin is located on the wall outside the main entrance – please use it but note that the entrance lobby must be kept clear while smoking.
- The Club cannot be held responsible for any loss or damage, however caused, to any property brought to or left on the premises under any circumstances.
- Please return this form (fully completed) for the attention of the Club Secretary, along with the requisite payment.
- Members enjoy approximately 10% discount against our standard bar prices, along with preferential treatment with regard to room hire and the use of other Club facilities.
- Membership runs from 1st January to 31st December. New members joining on or after 1st July will receive a 50% reduction on the rates shown.
- The Club also has a Bowling Green located in the heart of Alcester, membership of which is only available to members of the Club. Please ask about membership there; it does come at an additional cost, but is great value and an excellent place to spend a summer's afternoon or six!
